## Corporate Profile

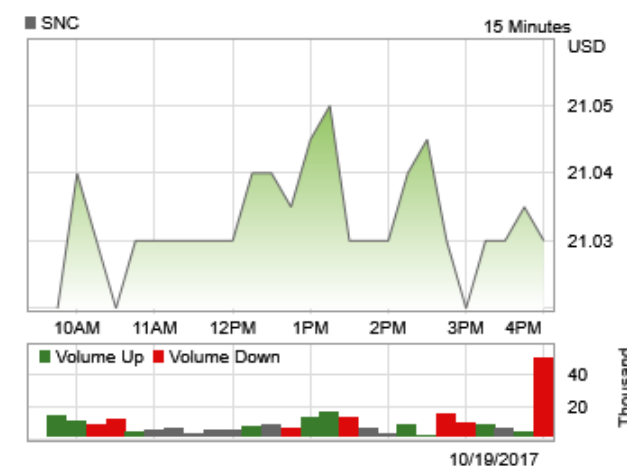
